2. Previous research suggests that meeting twice weekly for 50 minutes at a time made an Impact on the caregiver's ability to use language support strategies. Best outcomes occur when we work with families 1-2x per week (1 hour session) = 2 total hours per week
 - o Uncover can be adapted to or optimized to fit a family's needs?
 - o Do you think this would work for your family or community?
 - o Why? Why Not?
 - o What are the challenges you may have?
