Supplemental Material S1.

Speaker utterances, mean gender ratings, and media sources for the stimuli. Gender ratings were obtained from evaluators who rated the written utterances as to whether they thought the speaker was male or female using a 7-point Likert scale; 1 indicated "*Definitely a Male*," 7 indicated "*Definitely a Female*," and 4 indicated "*Neutral*." All included stimuli received average ratings between 3 and 5, suggesting that raters did not perceive the utterances as strongly gendered.
