The father has not seen a primary care provider in more than 2 years, denies any particular problems and lives alone. He takes an aspirin a day and hypertensive medication. The patient schedules an appointment to see a health care provider.

PA Examination reveals acuity decreased to whispered voice. TM with good cone of light. Weber midline. AC>BC. Examination of the ears showed no cerumen impaction and normal tympanic membranes.
